

## Projects promoting Human Rights - Information for applicants -

### 1. Basis for support

Germany is committed to protecting and promoting human rights across the world. To this end, the Federal Foreign Office makes available funding to support human rights projects. This money has to be used and accounted for in accordance with German budget law. Such funding may only be used for specific projects with a limited and clearly defined duration and content. It is not possible to provide institutional support for organisations working in human rights, for instance by assuming ongoing personnel or operating costs.

Sums of up to 150,000 euros can be granted for concrete projects.

Projects running over several years are, in general, not eligible for funding. Irrespective of when they are launched, projects must be completed by 31 December of each calendar year by the latest.

The funding of projects which have already started is, in principle, not possible.

There is no entitlement to support.

The human rights projects of the Embassy in Kyiv will pay special attention in 2024 at the consequences of the Russian war of aggression against Ukraine. This includes, for example, the promotion of psychological and medical support projects for victims of sexual violence, as well as support for internally displaced persons and children affected by war. Another focus is the support of particularly vulnerable groups, such as the elderly and disabled people, LGBTIQ+ and ethnic minorities.

### 2. Focuses of support

Projects can, for example, focus on the objectives identified in the German Government's Action Plan for Human Rights

For the purposes of submitting project applications, the objectives can be broken down into more specific aims, for example as follows:

a) Strengthening civil society, in particular supporting human rights defenders, human rights institutions and media, e.g. by

- supporting project activities run by human rights defenders
- promoting local, national and regional networks
- protecting journalism
- promoting freedom of opinion and of the press

b) Protecting and promoting the rights of women, e.g. by

- tackling discrimination on the grounds of gender
- combating trafficking in women
- supporting projects to combat “honour killings”
- supporting projects to combat inhumane traditional practices, e.g. genital mutilation
- countering/preventing violence against women, including in armed conflicts
- fostering gender equality and the political participation of women

c) Promoting and Implementation of the Agenda “Women, Peace and Security”, e.g. by

- supporting projects to implement the Action Plan of the Government of the Federal Republic of Germany on the Implementation of United Nations Security Council Resolution 1325 on Women, Peace and Security

supporting projects to strengthen women's participation in prevention, peace processes and post-conflict reconstruction  
preventing and combating sexualised and gender-based violence in conflicts

- d) Protecting and strengthening rights of sexual minorities, e.g. by
  - promoting local civil society organisations and networks
  - supporting projects related to protection and strengthening the human rights of LGBTIQ people
  - supporting projects combating and prosecuting violence against LGBTIQ people
  - supporting and promoting access to education, the right to have a family, freedom of assembly and the right to asylum
  
- e) Protecting and promoting children's rights, e.g. by
  - combating child trafficking, child labour and sexual exploitation
  - protecting children in armed conflicts
  
- f) Projects campaigning for a moratorium on the death penalty or its abolition, e.g. by
  - supporting seminars with German or European experts
  - supporting reforms in the judiciary and prison systems
  
- g) Economic, social and cultural rights (ESCR), e.g. by
  - supporting projects relating to the right to housing and water
  - supporting projects relating to the right to health
  - supporting projects relating to the right to education

### **3. Procedure**

Germany's missions abroad provide project application forms. This form must be completed carefully and in full and submitted promptly by the date set by the mission. Applicants should reckon on the procedure taking several months.

The application must be accompanied by a financial plan including a detailed list of project costs. Organisations' running costs (e.g. rental costs, salaries of permanent staff) cannot be funded, except if they are purely project-related! If possible, the organisation should cover some of the project costs using its own funds; if not, please explain why. Own funds should be described in relation to the total budget, not to individual budget items.

Once the Federal Foreign Office has approved the application, a funding agreement will be concluded under German law.

Once the project has been completed, proof of employment of funds must be given using the sample text available from the mission
